

- (I) ALLOTMENT AND ISSUE OF 316,873,999 NEW ORDINARY SHARES IN THE CAPITAL OF ASIAN MICRO HOLDINGS LIMITED TO LIM KEE LIEW @ VICTOR LIM; AND
- (II) ALLOTMENT AND ISSUE OF 60,000,000 NEW ORDINARY SHARES IN THE CAPITAL OF ASIAN MICRO HOLDINGS LIMITED TO LEONG LAI HENG.

1. INTRODUCTION

- 1.1 The Board of Directors ("Board") of Asian Micro Holdings Limited ("AMH" or "Company", and together with its subsidiaries, "Group") refers to the Company's announcements dated 8 March 2019, 26 March 2019, 10 April 2019 and 26 April 2019 on the Proposed Debt Conversion and issuance of Conversion Shares ("Announcements").
- 1.2 Unless otherwise defined herein, all capitalised terms used herein shall have the same meaning ascribed to them in the Announcements.

2. ISSUANCE AND ALLOTMENT OF 376,873,999 CONVERSION SHARES

- 2.1 Further to the Announcements, the Board wishes to announce the issuance and allotment of the following on 6 May 2019:
 - (i) 316,873,999 Conversion Shares have been issued and allotted to Lim Kee Liew @ Victor Lim; and
 - (ii) 60,000,000 Conversion Shares have been issued and allotted to Leong Lai Heng;
- 2.2 The Conversion Shares shall rank *pari passu* in all respects with all other existing Shares, except that the Conversion Shares shall not be entitled to any dividends, rights, allotments or other distributions, the record date of which is before the date of allotment of the Conversion Shares.
- 2.3 The Conversion Shares are expected to be listed and quoted on Catalist of the SGX-ST with effect from 9 May 2019 at 9.00 a.m.

3. CONCLUSION

Following the issuance and allotment of Conversion Shares, the Company's issued and paid-up share capital has increased from 688,308,796 Shares to 1,065,182,795 Shares.
